However, you are to adhere to the under-listed conditions:



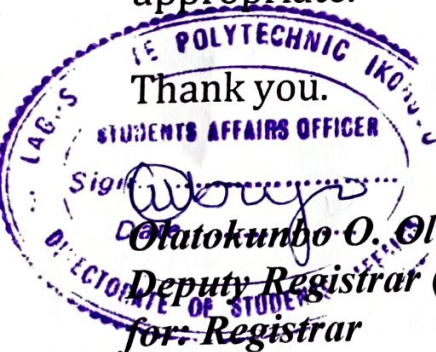
